Coach-Pitch (8U): A child cannot turn 9 years of age prior to January 1, 2024.

Fast Pitch (10U): A child cannot turn 11 years of age prior to January 1, 2024.

Fast Pitch (12U): A child cannot turn 13 years of age prior to January 1, 2024.

Fast Pitch (14U): A child cannot turn 15 years of age prior to January 1, 2024.

ALL LANGUAGE IN THIS DOCUMENT REFERS TO AN INDIVIDUAL "PARTICIPANT". IN THE CASE OF A MINOR UNDER THE AGE OF 18, "PARTICIPANT" REFERS TO THE PARENT OR LEGAL GUARDIAN FOR SAID INDIVIDUAL. PLEASE CHECK ONE OF THE FOLLOWING:

NOTE: NO INDIVIDUAL WILL BE ALLOWED TO PARTICIPATE IN ANY KIDS, INCORPORATED ACTIVITY UNTIL THIS FORM IS ON FILE IN THE KIDS, INCORPORATED OFFICE. REGISTRATION FORMS ARE CONSIDERED NULL AND VOID UNTIL A VALID COPY OF THIS DOCUMENT IS IN PLACE. THE WAIVER ASSOCIATED WITH THIS ACCOUNT SHALL REMAIN IN EFFECT PERMANENTLY UNLESS THE PARTICIPANT NOTIFIES THE KIDS, INCORPORATED OFFICE, IN WRITING, THAT THEY NO LONGER WISH TO AGREE TO THE WAIVER. AT THAT POINT, THE PARTICIPANT WILL NEED TO MAKE AN APPOINTMENT TO MEET WITH KIDS, INCORPORATED OFFICIALS TO DISCUSS THE MATTER BEFORE BEING ALLOWED TO PARTICIPATE IN ANY FUTURE PROGRAMS.

IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN ANY WAY IN A KIDS, INCORPORATED ACTIVITY ("ACTIVITY") I, FOR MYSELF, FOR PERSONAL REPRESENTATIVES, ASSIGNS, HEIRS, AND NEXT OF KIN:

- 1. ACKNOWLEDGE, AGREE, AND REPRESENT THAT I UNDERSTAND THE NATURE OF KIDS, INCORPORATED ACTIVITIES AND THAT I, AM QUALIFIED, IN GOOD HEALTH, AND IN PROPER PHYSICAL CONDITION TO PARTICIPATE IN SUCH ACTIVITY. I FURTHER AGREE AND WARRANT THAT IF AT ANY TIME I BELIEVE CONDITIONS TO BE UNSAFE, I WILL IMMEDIATELY DISCONTINUE FURTHER PARTICIPATION IN THE ACTIVITY.
- 2. FULLY UNDERSTAND THAT: (A) KIDS, INCORPORATED ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (B) THESE RISKS AND DANGERS MAY BE CAUSED BY MY OWN ACTIONS OR INACTION'S, THE ACTIONS OR INACTION'S OF OTHERS PARTICIPATING IN THE ACTIVITY, THE CONDITION IN WHICH THE ACTIVITY TAKES PLACE, OR THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (C) THERE MAY BE OTHER RISK AND SOCIAL AND ECONOMIC LOSSES EITHER NOT KNOWN TO ME OR NOT READILY FORESEEABLE AT THIS TIME; AND I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I INCUR AS A RESULT OF MY PARTICIPATION.

AGE AND/OR GRADE-BASED DISCREPANCIES

AT ANY TIME, AT THE SOLE DISCRETION OF KIDS, INCORPORATED, WE RESERVE THE RIGHT TO REQUIRE THE PARENT AND/OR LEGAL GUARDIAN TO SUBMIT AN ORIGINAL BIRTH CERTIFICATE, A CURRENT REPORT CARD, AND/OR A CURRENT SCHOOL-VALIDATED CLASS SCHEDULE TO VERIFY THE ACCURATE AGE/GRADE. FOR ADULT PARTICIPANTS, WE RESERVE THE RIGHT TO REQUIRE THE PARTICIPANT TO SUBMIT ONE OR MORE OF THE FOLLOWING VALID FORMS OF IDENTIFICATION: 1) DRIVER'S LICENSE FROM A U.S. STATE, 2) FEDERAL OR STATE ID CARD, 3) MILITARY ID CARD, 4) U.S. PASSPORT.

 ANY ACT OF VIOLENCE IS PROHIBITED.

 ACCEPT THE DECISION OF THE GAME OFFICIALS AS BEING FAIR AND CALLED TO THE BEST OF THEIR ABILITY.

 DO NOT KNOWINGLY PERMIT AN INELIGIBLE PLAYER TO PLAY IN ANY GAME.

 PLEASE USE GOOD SPORTSMANSHIP.
